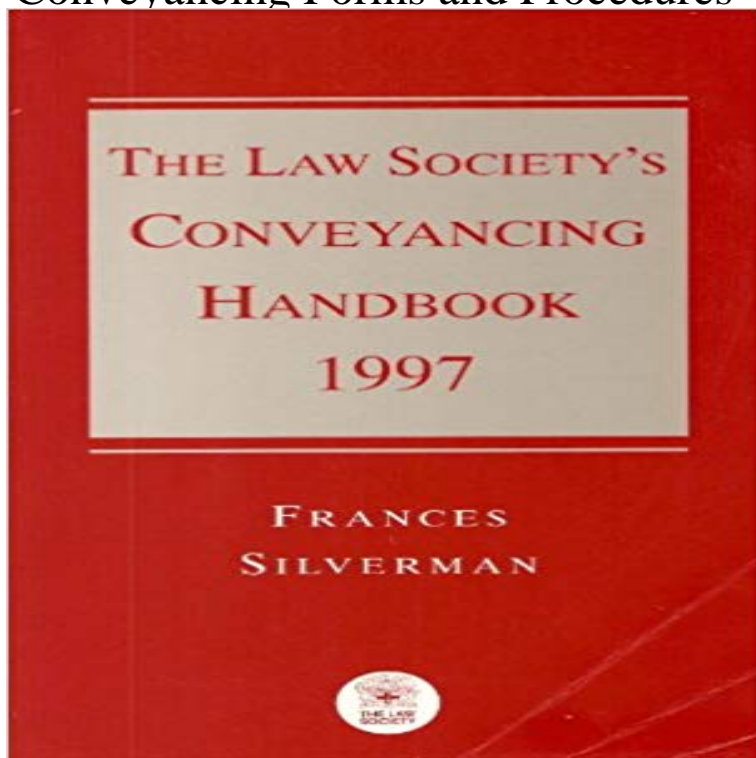


## Conveyancing Forms and Procedures
