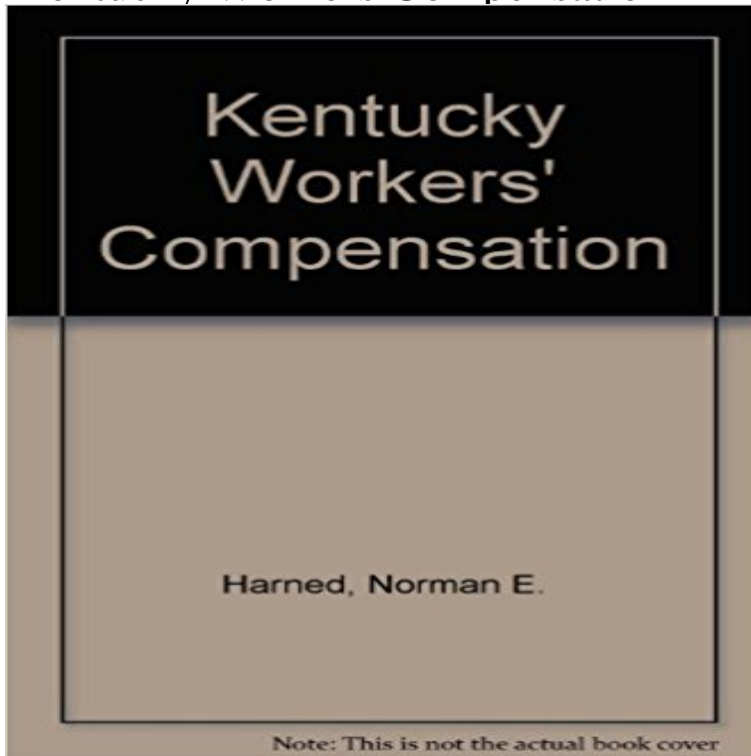


## Kentucky Workers Compensation
