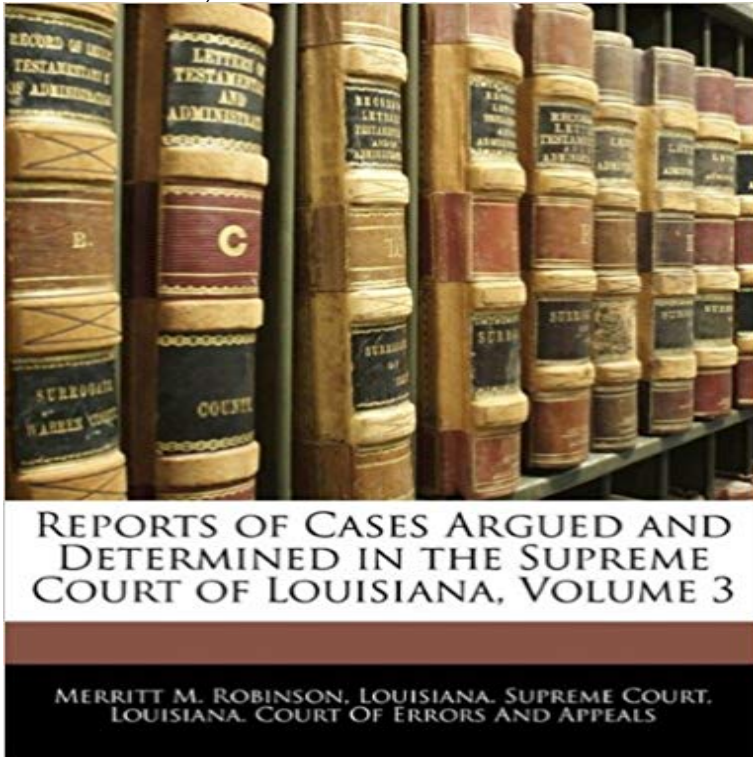


# Reports of Cases Argued and Determined in the Supreme Court of Louisiana, Volume 3
